RESOLUTION NO. 2008 - 140

OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED



Section 2. The Board of Commissioners authorizes the Chairman to otherwise perform all other acts necessary to accomplish the intent of this Resolution.


Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners.




