RESOLUTION NO. 2012 – 246

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ADJUST THE FEES AND CHARGES ASSOCIATED WITH PROGRAMS AND ACTIVITIES WITHIN THE CLAYTON COUNTY DEPARTMENT OF PARKS AND RECREATION; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County previously adopted a Fees & Charges Policy for the use of facilities, equipment, and the participation in programs sponsored by the Clayton County Department of Parks and Recreation; and

WHEREAS, the recommendation for a change in fees and charges of the following programs and activities is listed as follows:

International Park Recommendation:

Pavilions on the beach- reduce fee

St. John \$800 to \$500

St. Martin \$800 to \$500

St. Kitts \$700 to 400

Eliminated the minimum ticket purchase for beach pavilions

Special Event Fee (Walk/Run, Festivals, Car Shows, etc. -\$700)

Summer Camp Recommendation:

Weekly Resident Fee \$50 to \$55

Weekly Non-Resident Fee \$80

Athletics:

\$5.00 fee for background checks

\$25.00 non-resident fee across the Board

WHEREAS, the fees and charges associated with the programs and activities at the park have been reviewed and compared to surrounding jurisdictions fees and charges usage rates over the past year; and

WHEREAS, the recommendation of the newly established fees and charges are expected to increase the usage of the facilities at the Clayton County Parks and Recreation Department during the peak season and additionally provide some fees that may recoup additional revenue from non-county residents increasing the revenue in the General Fund; and

WHEREAS the County deems it in the best interest of the County, and the County will best be served by changing the fees and charges of these certain programs and activities.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes an adjustment of the fees and charges of certain programs and activities at the Clayton County Park and Recreation Department. The Board of Commissioners authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution. The Board of Commissioners also authorizes the Finance Director to amend the budget where necessary to reflect an appropriate revenue source and expense.

Section 2. This Resolution shall be immediately effective upon approval by the Board of Commissioners.
