 - b. HR Director Bright confirmed the request came in before the Civil Service Board would meet and that she had approved a one-month extension prior to the Board's meeting and explained in detail.
 - c. Warden Smith stated he was asking for a six-month extension
 - d. A discussion among the Board, Warden Smith and Officer Roberts occurred.
 - e. Chairman Bartlett called for a motion. Mr. Trimble made a motion to approve the request, second by Mr. Osagie. No further discussion on the motion made. Motion carried by unanimous vote.
- 10. Considered request from Fire Chief Landry Merkison to extend the probationary period of Zedrick Carter, Fire & Emergency Services, for six (6) months.
 - a. Fire Chief Landry Merkison explained the request in detail.
 - b. A discussion between the Board and Fire Chief Merkison occurred.
 - c. HR Director Bright confirmed Mr. Carter was notified of this meeting date.
 - d. Mr. Trimble made a motion to approve the request, second by Vice-Chair Lancaster. No further discussion on the motion made. Motion carried by unanimous vote.
