1. The meeting was called to order at 9:30 a.m.

- 2. The Board approved the appointment of Larry Bartlett as Chairman and Troyce Lancaster as Vice-Chair.
- 3. The Board adopted the agenda with an amendment: Add item 7(a) request from Police Chief Gregory Porter to extend the provisional appointments of listed employees.
- 4. The Board welcomed its newest member, Virginia Phillips-Hall.
- 5. The Civil Service Board's Meeting minutes held on December 3, 2014, were approved.
- 6. The Civil Service Board's Executive Session minutes regarding the Sonja R. Sanchez, Sheriff's Office, termination appeal hearing held on December 3, 2014, were approved.
- 7. The Civil Service Board's Decision regarding the Sonja R. Sanchez, Sheriff's Office, termination appeal was approved.
