## RESOLUTION NO. 2023-52

A RESOLUTION AUTHORIZING THE RE-ESTABLISHMENT OF THE POSITION OF "DEPUTY CHIEF OPERATIONS OFFICER"; TO AUTHORIZE THE CHAIRMAN TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Board of County Commissioners ("Board"), through Resolution 2019-17, abolished the position of "Deputy Chief Operating Officer" ("DCOO"), effective January 17, 2019; and

WHEREAS, the Board now believes that the workload placed upon current staff of the Office of the Board of Commissioners necessitates an additional position to support the Chief Operating Officer ("COO"); and

WHEREAS, the Board wishes to reorganize positions within the Office of the Board of Commissioners by reestablishing the DCOO position; and

WHEREAS, the position of DCOO will be selected by the COO, the DCOO will be tasked with assisting the COO with daily operations of government services, and the DCOO will report directly to the COO; and

WHEREAS, the DCCO will be responsible for assessing critical infrastructure, policy, economic, performance, emergency response, and preparedness challenges that are a part of 21st century county governance; and

WHEREAS, the DCOO will support the COO with the identification of strategies that prepare Clayton County residents, communities, institutions, businesses, and systems to survive, adapt, and support the strategic initiatives of the Board; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by re-establishing the Deputy Chief Operating Officer position for the stated purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the re-establishment of the position of Deputy Chief Operating Officer for the Office of the Board of Commissioners, to report directly to the Chief Operating Office, for the purpose of assisting the Chief Operating Officer with daily operations of government services to include, among other things, assessing critical infrastructure, policy, economic, performance, emergency response, and preparedness challenges and identifying strategies that prepare Clayton County residents, communities, institutions, businesses, and systems to survive, adapt, and support the strategic initiatives of the Board. The Deputy Chief Operating Officer shall report directly to the Chief Operating Officer.

Section 2. The Board of Commissioners further authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution. The Board of Commissioners also authorizes the Chief Financial Officer to amend the Budget to reflect an appropriate revenue source and expense as necessary

Section 3. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
