RESOLUTION NO. 2023 – 86

A RESOLUTION AUTHORIZING AN AMNESTY DAY INITIATIVE FOR TRASH/DEBRIS DISPOSAL; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ALL DOCUMENTS NECESSARY AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Board of Commissioners of Clayton County (the "Board"), through Resolution 2023-68, established designated dates for trash/debris disposal for Clayton County residents at strategic locations with a tipping and fee waiver at the landfill, (known as "Amnesty Day Initiative"); and

WHEREAS, the Amnesty Day Initiative was to occur on April 8 and April 9 for residents in Clayton County Districts 1 and 2, as well as April 15, and April 16, 2023 for residents in Districts 3 and 4; and

WHEREAS, on April 8 and 9, the residents in Clayton County Districts 1 and 2 were unable to take part in the Amnesty Day Initiative due to poor weather; and

WHEREAS, the Board desires to reschedule the Amnesty Day Initiative for residents in Clayton County Districts 1 and 2 at the following locations, dates and times:

District 1

District 2

Sat., April 22, 2023 (9 a.m. - 1 p.m.); and

WHEREAS, Code Enforcement Officers will supervise locations and address

constituent questions; and

WHEREAS, the Police Department will monitor traffic coming into and going out

of designated disposal sites; and

WHEREAS, the Transportation and Development Department will monitor and

facilitate the transport of the roll-off dumpsters; and

WHEREAS, the items accepted at the disposal locations will include white goods

(major household electrical appliances) and furniture; and

WHEREAS, Clayton County off-duty personnel may volunteer for overtime hours

so as to not impact normal operations; and

WHEREAS, the Amnesty Day Initiative details will be timely communicated to

constituents; and

WHEREAS, the County deems it in the best interest of the County and the County

will be served by re-enacting the Amnesty Day Initiative for Commissioner Districts 1 and

2.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to re-

enact the Amnesty Day Initiative for Clayton County Commissioner Districts 1 and 2. The

times:

Section 2. The Board also authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution.
