RESOLUTION NO. 2023 - 117

A RESOLUTION OF THE BOARD OF COMMISSIONERS TO INITIATE A REZONING OF THE PROPERTY LOCATED AT 10466 TARA BOULEVARD, JONESBORO, GA 30236 (TAX PARCEL #06094 095014) FROM AG (AGRICULTURE) TO GB (GENERAL BUSINESS); TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Board of Commissioners has the authority under O.C.G.A. § 36-66-4 to amend its Zoning Ordinance codified in Appendix A of the Clayton County Code; and

WHEREAS, from time to time, the Board of Commissioners determines that it is in the best interest of the citizens of Clayton County to initiate text and map amendments to the Zoning Ordinance; and

WHEREAS, the County rezoned 10466 Tara Boulevard, Jonesboro, GA 30236, Tax Parcel #06094 095014 (“Property”) from Heavy Industrial (“HI”) to Agriculture (“AG”) as a part of the adoption of the 2008 Zoning Ordinance and;

WHEREAS, the current Property owner has owned a billboard on the Property since 1981; and

WHEREAS, the current zoning of the property is not consistent with the current use of the property and, likely, was rezoned in error; and

WHEREAS, this rezoning will allow the zoning for the Property to be consistent with the Property’s current use: General Business (“GB”); and

WHEREAS, the Board of Commissioners deems it in the best interest of the citizens of Clayton County, and the County will best be served by initiating the foregoing rezoning of the aforementioned mentioned Property from AG to GB.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA, AND IT IS HEREBY RESOLVED

Section 1. Pursuant to provisions of Georgia law and the Clayton County Code of Ordinances, the Board of Commissioners hereby directs appropriate staff to initiate a rezoning of the property located at 10466 Tara Boulevard, Jonesboro, GA 30236, Tax Parcel #06094 095014, from Agriculture (“AG”) to General Business (“GB”) along with any appropriate text or map amendments.

Section 2. This Resolution shall become effective upon its approval by the Board of Commissioners.


