## RESOLUTION NO. 2023-126

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO GRANT A SPECIAL FACILITY USE REQUEST TO THE WOMEN OF CLAYTON COUNTY FOR THE USE OF CERTAIN ELECTRONIC DIRECTIONAL ROAD TRAFFIC SIGNS AND PORTABLE STAGE AT THE JONESBORO ART FESTIVAL; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, a Special Facility Use Request (the "Request") was received from The Women of Clayton County ("Promoter") for use of certain electronic directional road traffic signs, as well as, a portable, outdoor stage (together "Facilities") at the Jonesboro Arts Festival on Main Street, taking place on Friday, September 2<sup>nd</sup> through Monday, September 4<sup>th</sup>, 2023 ("Event"); and

WHEREAS, the Promoter would like the use of the electronic directional road traffic signs at the Event from Friday, September 1<sup>st</sup> at 6:00 P.M. until Monday, September 4<sup>th</sup> at 10:00 P.M in the north and southbound lanes of Main Street in downtown Jonesboro, Georgia; and

WHEREAS, the Promoter would like the use of the portable stage at the Event from Friday, September 1<sup>st</sup> at 6:00 P.M. until Monday, September 4<sup>th</sup> at 5:00 P.M at the intersection of Main Street and Mill Street in downtown Jonesboro, Georgia.; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served, by granting the Promoter's request to use the Facilities for the Promoter's Event.

## NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to grant a Special Facility Use Request to The Women of Clayton County for use of certain electronic directional road traffic signs, as well as, a portable, outdoor stage at the Jonesboro Arts Festival on Main Street event. The aforementioned event will take place on Friday, September 2<sup>nd</sup> through Monday, September 4<sup>th</sup>, 2023.

Section 2. The Board further authorizes the Chairman to execute any documents and perform any other acts necessary to accomplish the intent of this Resolution.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements, if any, prior to the initial event date as provided by Clayton County Risk Management.
