RESOLUTION NO. 2023-169

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO GRANT A SPECIAL FACILITY USE REQUEST TO NOURISHING HANDS INC TO HOST AN EVENT AT THE LAKEVIEW EVENT CENTER; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, a Special Facility Use Request (the "Request") was received from Nourishing Hands Inc. ("NHI"), a nonprofit corporation, for use of the second floor of the Lakeview Event Center (the "Facility") for the purpose of holding an event (the "Event") on October 28, 2023; and

WHEREAS, NHI would like to use the Facility from 6 o'clock P.M. until 9 o'clock P.M.; and

WHEREAS, due to the nature of NHI being a nonprofit corporation whose purpose is to work with the Clayton County community and citizens to offer quality and affordable programs for the benefit of the community at large, NHI requests that any facility use charges be waived; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by granting the Request to use the Facility and allowing NHI to facilitate this Event at no cost.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to grant a Special Facility Use Request to Nourishing Hands Inc. for use of the second floor of the

Lakeview Event Center to host an appreciation dinner for Clayton County Foster Parents. The Event will take place on Saturday, October 28, 2023, from 6 o'clock P.M. until 9 o'clock P.M.

Section 2. The Board of Commissioners authorizes the County to grant this Special Facility Request to Nourishing Hands Inc. free of charge. The Board further authorizes the Chairman to execute any documents and perform any other acts necessary to accomplish the intent of this Resolution.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements, if any, prior to the initial event date as provided by Clayton County Risk Management.
