Director Dozier informed the Board that on Election Day, Poll Workers and the Election Staff wore teal Clayton County Board of Elections VOTE Shirts in honor of the Commissioner Sonna Singleton Gregory.

Director Dozier informed the Board that the month of September and the color teal are associated with Ovarian Cancer and Polycystic Ovarian Syndrome Awareness.

Director Dozier informed the Board that there was a 5.37% voter turnout for Commission District 1 and a 6.07% voter turnout for Board of Education District 8 for the September 21, 2021 Special Election.

Director Dozier informed the Board that there will be a runoff election on Tuesday, October 19, 2021 because none of the candidates received 50% of the votes.

Director Dozier informed the Board that Early Voting for the runoff will start on Tuesday, October 12, 2021 and end on Friday, October 15, 2021.

Director Dozier informed the Board that due to Senate Bill 202, the office is not able to start Early Voting on Monday, October 11, 2021 because it is a State Holiday.

Director Dozier informed the Board that the same Early Voting sites will be used for the runoff that were used during the September 21, 2021 Special Election.
