Director Dozier informed the Board that the City of Forest Park had expressed interest in using the office's voting equipment for them to conduct their municipal election in November 2023.

Director Dozier informed the Board that on May 8, 2023, the office had its budget meeting with the county's finance department.

Director Dozier informed the Board that the Finance Department showed interest and support for the office's request, including salary increases and purchasing new election equipment.

Director Dozier informed the Board that during the meeting with the finance department, Registrar Manager Brown brought up that the recent signing of Senate Bill 129 requires the Election office to conduct audits after every election where a State or Federal candidate is on the ballot.

Director Dozier informed the Board that Attorney Reed would give an update on the legislative changes at the next meeting in June.

Director Dozier informed the Board that the Finance Department favored increasing Poll Worker Pay.

Director Dozier informed the Board that the office recommended an increase of fifty dollars for Poll Workers to stay competitive with surrounding counties.

Board Member Hope inquired about the current pay rate of Poll Workers.

Registrar Manager Brown informed the Board that the compensation for clerks is \$165, Assistant Managers is \$240, and Managers \$315 for each Election Day.

Director Dozier informed the Board that Fayshawne Walker had taken a position with the Clayton County IT department to teach software to the community and fellow county employees.

Director Dozier informed the Board that she spoke with the new Director of IT about working together to provide Voter Education classes for the public and county employees.

Director Dozier informed the Board that until the Community Outreach position is filled, Fayshawne will still make the office's social media announcements.

Secretary Walker inquired when the information would be available for the 2024 GAVREO Conference.

Director Dozier informed the Board that the GAVREO committee is planning the timeline and dates, with the first timeline being July 7, 2023, to ensure the theme and topics for the conference.

Director Dozier informed the Board that the information for the GAVREO conference should be available in August or September 2023.






