A. Certification of the Election-General / Special Election held November 7, 2023

Director Dozier informed the Board that the Elections Office conducted the Elections for The City of Morrow and the Clayton County portion of The City of College Park, as well as a Countywide Special Election.

Director Dozier informed the Board there was a 4.84% turnout for the November 7, 2023 Election.

Director Dozier informed the Board that fifteen (15) Provisionals were reviewed, and of that total, eleven (11) were accepted.

Director Dozier informed the Board that a situation at the Morrow 02 Precinct on election day resulted in the scanner being jammed.

Director Dozier informed the Board that the Poll Manager and Poll Workers immediately reverted to the backup procedures when the scanner jammed, and voting did not stop.

Director Dozier informed the Board that due to the jammed scanner, the Vote Review Panel conducted an audit as a good-faith effort to ensure advocacy and transparency.
