## RESOLUTION NO. 2008 - 32

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO AN AGREEMENT WITH ATLANTA TECHNICAL COLLEGE PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH LEARNING EXPERIENCES FOR THE EMT-I/PARAMEDIC CLINICAL STUDENTS OF ATLANTA TECHNICAL COLLEGE ARE PROVIDED; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT AND OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT THE APPROPRIATIONS AND EXPENDITURES RELATING THERETO; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Atlanta Technical College (the "College") would like to establish a working relationship between the Clayton County Fire Department (the "Department") and the College in which learning experiences for EMT-I/Paramedic clinical students of Atlanta Technical College are provided; and

WHEREAS, the Department agrees to allow the students of the College the privilege of clinical experience while observing on a Clayton County Fire EMS response unit so as to assist the students in improving their skills and knowledge; and

WHEREAS, the Clayton County Fire Department is qualified and would be willing to provide such services; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by entering into an Agreement with Atlanta Technical College for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the County on behalf of the Clayton County Fire Department to enter into an Agreement with Atlanta Technical College providing for learning experiences for the EMT-I/Paramedic clinical students of Atlanta Technical College are provided. The Board of Commissioners hereby authorizes the Chairman to execute the Agreement and otherwise perform all other acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Director of Finance to amend the budget where necessary to reflect the appropriations and expenditures relating thereto. The Agreement shall be in substantially the form attached hereto, subject to such minor changes, insertions or deletions as the Chairman of the Board of Commissioners may approve.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
