## **ORDINANCE NO. 2009 - 29**

AN ORDINANCE TO MODIFY THE CLAYTON COUNTY CODE OF ORDINANCES DELETING PART II, CHAPTER 2, ARTICLE II, SECTION 2-32 "DAYS, TIME AND PLACE OF ZONING MEETINGS" OF THE CLAYTON COUNTY CODE OF ORDINANCES AS AMENDED AND SUBSTITUTING IN LIEU THEREOF A NEW CODE SECTION 2-32 "DAYS, TIME AND PLACE OF ZONING MEETINGS"; TO REPEAL CONFLICTING LAWS, ORDINANCES AND RESOLUTIONS; TO PROVIDE SEVERABILITY; TO PROVIDE AN EFFECTIVE DATE; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Board of Commissioners now desires to amend Part II, Chapter 2, Article II, Section 2-32 "Days, time and place of zoning meetings" of the Clayton County Code of Ordinances by changing the date of its regular meeting for consideration of matters pertaining to zoning from the second Thursday after the second Monday in each month to the second Tuesday in each month; and

WHEREAS, the Board of Commissioners further desires that the time and location of the zoning meetings, previously established as 7:00 p.m. at 112 Smith Street, Jonesboro, Georgia, will not change; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County and the County will best be served by amending the Code for the above stated purpose.

NOW THEREFORE, BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY ORDAINED:

Section 1. The Code of Ordinances of Clayton County, Georgia, as amended, is hereby further amended by modifying Part II, Chapter 2, Article II, Section 2-32 "Days, time and place of zoning meetings" by deleting existing Code Section 2-32 and substituting in lieu thereof a new Code Section 2-32 "Days, time and place of zoning meetings" which shall read as follows:

"Sec. 2-32. Days, time and place of zoning meetings.

The Board of Commissioners will hold its regular scheduled meeting for consideration of matters pertaining to zoning on the second Tuesday of each month at 7:00 p.m. at 112 Smith Street, Jonesboro, Georgia."

Section 2. All laws, ordinances and resolutions, or parts thereof, which conflict with the provisions of this Ordinance are hereby repealed.

If any part of this Ordinance shall be declared unconstitutional by the Section 3. valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect the remainder of this enactment, and such remainder shall remain in full force and effect.

Section 4. This Ordinance shall become effective March 10, 2009.
