RESOLUTION NO. 2009 - 103

A RESOLUTION AUTHORIZING THE SALE OR OTHER DISPOSITION OF CONDEMNED OR SEIZED VEHICLES TO BE SOLD AT AUCTION; TO AUTHORIZE THE SALE OF SUCH PROPERTY IN A MANNER AS WILL BE IN THE BEST INTEREST OF THE COUNTY; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Police Drug/Gang Violence Task Force seized a 2002 Ford Focus, VIN # 3FAFP31332R168725; a 1973 Chevrolet Nova, VIN # 1X27H3L121600; a 1990 Honda Accord, VIN # 1HGCB765XLA129446; and a 1975 Chevrolet Corvette, VIN # 1Z37J5S435701, via Civil Action 2008CV05104-9, of which these certain vehicles are not acceptable to be put in service as County vehicles, and it is advisable to sell or otherwise dispose of the vehicles ("unserviceable vehicles"); and

WHEREAS, it is hereby determined that the vehicles sought to be disposed of can not be effectively used for the benefit of the County, and no substantial County or public purpose will be served in the future by these vehicles; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by disposing of the unserviceable vehicles at auction in accordance with applicable County Ordinance.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED



interest of the County, and in accordance with provisions of Sec. 2-147 of the Clayton County Code of Ordinances.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.






