RESOLUTION NO. 2010 - 237

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A COOPERATION AGREEMENT WITH THE CITY OF JONESBORO AND TO SUPPORT THEIR EFFORTS TO SECURE GRANT FUNDS FROM THE GEORGIA RECREATIONAL TRAILS PROGRAM UNDER WHICH THE CITY OF JONESBORO WILL RECEIVE ASSISTANCE FOR THE CONSTRUCTION OF RECREATIONAL TRAILS; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the City of Jonesboro wishes to apply for grant funds from the Georgia Recreational Trails Program to provide for funding of the construction of recreational trails through the Stately Oaks, Battleground Park area, located within Clayton County, Georgia; and

WHEREAS, the Georgia Recreational Trails Program has been established to provide and maintain recreational trails and trails-related facilities identified in, or that further the goal of, the Statewide Comprehensive Outdoor Recreation Plan, as required by the Federal Land and Water Conservation Fund Act; and

WHEREAS, Clayton County wishes to support the City of Jonesboro in their efforts to secure funding for the above stated purpose and to cooperate with the City of Jonesboro in undertaking community renewal in support of recreational areas, and in support of tourism; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by entering into a Cooperation Agreement with the City of Jonesboro for the above stated purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Clayton County Board of Commissioners authorizes the County to enter into a Cooperation Agreement with the City of Jonesboro and to support their efforts to secure

grant funds from the Georgia Recreational trails Program under which the City of Jonesboro will receive assistance for the construction of recreational trails through the Stately Oaks, Battleground Park area. The Board of Commissioners hereby authorizes the Chairman to execute the agreement and to perform all other acts necessary to accomplish the intent of this Resolution.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


