A RESOLUTION PROVIDING FOR THE ESTABLISHMENT AND PUBLICATION OF QUALIFYING FEES FOR EACH COUNTY OFFICE TO BE FILLED IN THE UPCOMING GENERAL PRIMARY AND ELECTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, pursuant to the provisions of O.C.G.A. §21-2-131, it is the duty of the governing authority to fix and publish a qualifying fee for each County office to be filled in the upcoming primary and general election; and

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY, GEORGIA, AND IT IS HEREBY RESOLVED

Section 1. In accordance with the provisions of O.C.G.A. §21-2-131(a), the Board of Commissioners hereby sets and publishes the qualification fees for each County office to be filled in the upcoming primary general election. Except as otherwise provided in subparagraph (B), such fee shall be three (3%) percent of the total gross salary of the office, including all supplements, paid in the preceding year. In the case of the Judge of the Probate Court, Chief Judge of the Magistrate Court, Sheriff, Clerk of the Superior Court and Tax Commissioner, the qualifying fee shall be three (3%) percent of the minimum salary exclusive of supplements, cost-of-living and longevity increases. The following list represents the various offices and corresponding qualification fees:
