RESOLUTION NO. 2012 - 106

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO REDUCE THE FEE CHARGED FOR ENTRANCE INTO THE CLAYTON COUNTY INTERNATIONAL PARK ON LABOR DAY; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County has agreed to allow the Caribbean Association of Georgia to host the Fourth Annual South Metro Caribbean Festival (“the Festival”) at Clayton County International Park (“the Beach”) on Labor Day, September 1, 2012, between the hours of 1:00 p.m. and 8:00 p.m. and wishes to reduce the entrance fee to \$5.00 per person, with the exception of children under the age of two (2), who shall be admitted at no cost; and

WHEREAS, the Festival meets the mission of Clayton County Parks and Recreation in its vision to offer diverse programs to the citizens of Clayton County, enhance cultural awareness and promote community involvement; and

WHEREAS, the Festival includes a community service component by encouraging attendees to donate soft toys for the Family and Children Services in Clayton County, Haitian Children and the Children’s Homeless Shelter in Atlanta, as well as providing free dental checkups; free blood pressure checks, diabetes education and other services; and

WHEREAS, the Festival will include entertainment, games and contests to encourage patrons to choose the Beach as a destination spot on Labor Day and; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by reducing the entrance fees to \$5.00 per person, with the exception of children under the age of two (2), who shall be admitted at no cost.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to reduce the entrance fee to \$5.00 per person, with the exception of children under the age of two (2), who shall be admitted at no cost, on Labor Day, September 1, 2012, at the Clayton County International Park ("the Beach"). The Board of Commissioners authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be immediately effective upon approval by the Board of Commissioners.
