RESOLUTION NO. 2012 - 169

A RESOLUTION AUTHORIZING THE SALE OR OTHER DISPOSITION OF CONDEMNED VEHICLES FROM THE CLAYTON COUNTY POLICE DEPARTMENT TO BE SOLD AT AUCTION; TO AUTHORIZE THE DIRECTOR OF CENTRAL SERVICES TO EFFECT THE SALE OF SAID VEHICLES AS SURPLUS ITEMS; TO AUTHORIZE THE DISBURSEMENT OF PROCEEDS FROM THE SALE OF SUCH PROPERTY; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Police Department seized a Tan 1998 Chevrolet Blazer (VIN: IGNCS13W5W2207680) and a Silver 2000 Mitsubishi Eclipse GT (VIN: 4A3AC54L0YE083941) during two separate criminal investigations; and

WHEREAS, the Clayton County Police Department did petition the District Attorney for forfeiture of said vehicles to the County; and

WHEREAS, the Superior Court of Clayton County has forfeited ownership and title of said vehicles to the County under court order in case numbers 2011-CV-04396-9 and 2010-CV-00207-6; and

WHEREAS, the Director of Fleet Maintenance has evaluated and determined said vehicles are unsuitable for service as County vehicles and recommended the vehicles be sold; and

WHEREAS, it is hereby determined that the vehicles sought to be disposed of cannot be effectively used to benefit of the County, and no substantial County or public purpose will be served in the future by these vehicles; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by disposing of the unserviceable vehicles at auction in accordance with applicable County Ordinance with the proceeds from said auction to be placed into the 221 account to be used to enhance law enforcement in accordance with applicable State Statutes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby authorizes Clayton County, to auction the Tan 1998 Chevrolet Blazer (VIN: 1GNCS13W5W2207680) and a Silver 2000 Mitsubishi Eclipse GT (VIN: 4A3AC54L0YE083941). The auction shall be conducted in a manner as will be in the best interest of the County, and in accordance with provisions of Section 2-146 of the Clayton County Code of Ordinances. The proceeds of the auction of these unserviceable vehicles shall be tendered to the County and placed into the 221 account. The Directors of Central Services and Finance are authorized to perform all acts necessary to effect this resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
