RESOLUTION NO. 2012- 204

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A MEMORANDUM OF UNDERSTANDING (M.O.U.) WITH THE UNITED STATES BUREAU OF ALCOHOL, TOBACCO, FIREARMS AND EXPLOSIVES (ATF) TO PARTICIPATE IN A JOINT TASK FORCE TO FOCUS ON VIOLENT CRIMES AND FIREARMS TRAFFICKING WITHIN THE COUNTY; TO AUTHORIZE THE CHAIRMAN OR THE CHIEF OF POLICE AS HIS DESIGNEE TO EXECUTE THE M.O.U. AND OVERTIME AUTHORIZATION AGREEMENT; AND OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE FINANCE DIRECTOR TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE ALL AS MAY BE REQUIRED UNDER THE TERMS OF THE M.O.U. AND THE OVERTIME AUTHORIZATION AGREEMENT; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the United States Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) has created a Task Force to target crimes of violence and firearms trafficking with participation from various area law enforcement agencies; and

WHEREAS, the Clayton County Police Department has been invited to participate in this valuable program; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County and the County will best be served by entering into a Memorandum of Understanding with ATF for the stated reasons.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the Chairman of the

Board of Commissioners, or the Chief of Police as the Chairman's designee, to execute a Memorandum of Understanding (MOU) with the United States Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) to participate in the joint task force. The ATF will reimburse the County for overtime payments subject to the availability of funds. The Board of Commissioners also authorizes the Chairman, or the Chief of Police as his designee, to otherwise perform all acts necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners authorizes the Director of Finance to amend the budget where necessary to reflect an appropriate revenue source and expense, all as may be required under the terms of the agreement.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
