RESOLUTION NO. 2013 - 80

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO APPROVE A PARTNERSHIP WITH PROJECT ARM TO HOST AND SPONSOR A "LIFE'S A FISH & THEN YOU FRY" EVENT AT THE CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Parks and Recreation Department solicited information from Project ARM (Atlanta Renaissance Movement), Inc. (the "Promoter") regarding use of space on July 6, 2013 at Clayton County International Park (the "Location") for the purpose of hosting and sponsoring a "Life's a Fish & Then You Fry" event, to be held in conjunction with the Parks and Recreation Department; and

WHEREAS, Clayton County has traditionally supported the work of various non-profit organizations, governmental agencies, and professional service providers located and conducting business in Clayton County for the benefit of the County's citizens; and

WHEREAS, the Promoter wishes to utilize the Location on July 6, 2013 for the cooking event, live musical entertainment, a fireworks show, promotional and selling vendors, food vendors and other activities; and

WHEREAS, the Promoter is qualified to organize and facilitate projects that contribute positively to the community's morale and promote community involvement by offering positive, family-friendly cultural and musical entertainment; and

WHEREAS, the County will pay to the Promoter an up-front payment of \$4,000.00;  
and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by partnering with the Promoter to host and sponsor this event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County, through its Parks and Recreation Department, to partner with Project ARM (Atlanta Renaissance Movement), Inc. (the “Promoter”) to host and sponsor a “Life’s a Fish & Then You Fry” event on July 6, 2013 at Clayton County International Park (the “Location”), to be held in conjunction with the Parks and Recreation Department.

Section 2. The Board of Commissioners authorizes the Chairman to execute the License Agreement attached hereto as Attachment “A” and otherwise perform all other acts necessary to accomplish the intent of this Resolution.


