RESOLUTION NO. 2013 - 189

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE BOARD OF REGENTS OF THE UNIVERSITY SYSTEM OF GEORGIA, BY AND ON BEHALF OF CLAYTON STATE UNIVERSITY, PROVIDING FOR THE TERMS AND CONDITIONS UNDER WHICH STUDENTS IN THE SCHOOL OF NURSING WILL ACQUIRE APPLIED LEARNING EXPERIENCE BY WORKING WITH SENIOR ADULTS THROUGH THE CLAYTON COUNTY SENIOR SERVICES DEPARTMENT; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE MEMORANDUM OF UNDERSTANDING AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County has traditionally endorsed and supported the work of various nonprofit organizations, governmental agencies, and professional service providers located and conducting business in Clayton County for the benefit of the County's citizens; and

WHEREAS, the County's Senior Services Department has expressed interest in partnering with Clayton State University to allow Clayton State Nursing students who are in their final semester to acquire Applied Learning Experience by assisting the County's Senior Services staff in conducting health awareness classes and health fairs, as well as identifying, monitoring and educating seniors at high risk of developing hypertension; and

WHEREAS, Clayton State University is qualified to organize and facilitate educational training programs that promote and inspire excellence in the field of nursing for senior adults; and

WHEREAS, there will be no funding required of the County; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by entering into the Memorandum of Understanding as contemplated therein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the County to enter into a Memorandum of Understanding with the Board of Regents of the University System of Georgia whereby the County will partner with Clayton State University to allow Clayton State Nursing students, who are in their final semester, to acquire Applied Learning Experience by assisting the County's Senior Services staff in conducting health awareness classes and health fairs, as well as identifying, monitoring and educating senior adults who are at high risk of developing hypertension. The Board of Commissioners hereby authorizes the Chairman to execute the Memorandum of Understanding and to perform all other acts necessary to accomplish the intent of this Resolution. The Memorandum of Understanding shall be in substantially the form attached hereto, subject to such minor changes, insertions or deletions as the Chairman of the Board of Commissioners may approve.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
