RESOLUTION NO. 2013 - 213

A RESOLUTION AUTHORIZING CLAYTON COUNTY, ON BEHALF OF THE CLAYTON COUNTY PARKS AND RECREATION DEPARTMENT, TO GRANT A SPECIAL FACILITY USE REQUEST FOR VIRTUAL OIF/OEF VETERANS ORGANIZATION, INC. TO HOST A VETERANS HEALTH FAIR AT THE CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Parks and Recreation Department received a Special Facility Use Request from Virtual OIF/OEF Veterans Organization, Inc. (the "Request") for use of the St. Bart and Bermuda Pavilions and the Upper Field at the Clayton County International Park (the "Park") for the purpose of hosting a Veterans Health Fair for combat veterans and their families; and

WHEREAS, Clayton County has traditionally supported the work of various non-profit organizations, governmental agencies, and professional service providers located and conducting business in Clayton County for the benefit of the County's citizens; and

WHEREAS, the Park space will be utilized between the hours of 8:00 a.m. to 4:00 p.m. on October 5, 2013; and

WHEREAS, the Director of the Parks and Recreation Department recommends that Virtual OIF/OEF Veterans Organization, Inc. pay the half price, non-profit rate for the Special

Event Fee (\$350.00), and will pay for the services of two maintenance staff persons (\$10 each per hour for eight hours—\$160.00) and one coordinator for safety and security purposes (\$10 per hour for eight hours—\$80.00) during the event; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by granting the Request to use the Park space for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, on behalf of the Clayton County Parks and Recreation Department, to grant Virtual OIF/OEF Veterans Organization, Inc. a Special Facility Use Request to host a Veterans Health Fair for combat veterans and their families at the St. Bart Pavilion, Bermuda Pavilion and the Upper Field at the Clayton County International Park on October 5, 2013, and also authorizes the Chairman to execute any documents and perform any other acts necessary to accomplish the intent of this Resolution.

Section 2. Virtual OIF/OEF Veterans Organization, Inc. will pay the half price, non-profit rate for the Special Event Fee (\$350.00), and will pay for the services of two maintenance staff persons (\$10 each per hour for eight hours—\$160.00) and one coordinator for safety and security purposes (\$10 per hour for eight hours—\$80.00) during the event.






