A RESOLUTION TO ALLOW UTOPIAN ACADEMY FOR THE ARTS TO HOST COMMUNITY MEETINGS AT THE VIRGINIA BURTON GRAY RECREATION CENTER; TO AUTHORIZE THE CHAIRMAN AND THE DIRECTOR OF THE PARKS AND RECREATION DEPARTMENT TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, representatives of Utopian Academy for the Arts (the "Host") wish to utilize the Virginia Burton Gray Recreation Center (the "Location") to host community meetings to provide information regarding the opening of Utopian Academy for the Arts, a charter school, in Clayton County; and

WHEREAS, the Host wishes to utilize the Location in Riverdale, Georgia on February 12, 2014 and February 22, 2014 from approximately 6:00 P.M. until 8:00 P.M; and

WHEREAS, the Host requested that all fees for the use of the Location be waived, however, the Director of Parks & Recreation (the "Department") is requesting consideration by the Board of Commissioners to approve the Department's facility use cost of \$200.00, which is the rate for non-profit organizations; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing the Host to facilitate these meetings.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners agrees to allow representatives of Utopian Academy for the Arts to host community meetings on February 12 and 22, 2014 at the Virginia Burton Gray Recreation Center to provide information regarding the opening of Utopian Academy for the Arts in Clayton County. The Board of Commissioners authorizes the Chairman and the Director of the Parks and Recreation Department to perform all acts necessary to accomplish the intent of this Resolution.

<u>Section 2</u>. The facility use cost of \$200.00 is to be charged to Utopian Academy for utilizing the Virginia Burton Gray Recreation Center.

<u>Section3.</u> This Resolution shall be immediately effective upon approval by the Board of Commissioners.
