RESOLUTION NO. 2014-52

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO TWO LICENSE AGREEMENTS WITH CHALLENGER SPORTS CORPORATION TO UTILIZE THE VOLLEYBALL AREA AT CLAYTON COUNTY INTERNATIONAL PARK TO HOST A BEACH SOCCER CAMP AND A BEACH SOCCER TOURNAMENT; TO AUTHORIZE THE CHAIRMAN TO OTHERWISE PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, representatives of Challenger Sports Corporation (the "Promoter") wish to utilize the volleyball area at Clayton County International for a TetraBrazil Beach Soccer Camp and a Beach Soccer Tournament (the "Events") from June 2 through 6, 2014 from 9:00 a.m. to 4:00 p.m., and from June 6 through June 8, 2014 from 7:00 a.m. to 7:00 p.m., respectively; and

WHEREAS, the Director of the Parks and Recreation Department (the "Department") is requesting consideration by the Board of Commissioners to approve the Department's recommended event rental fee of a total of \$3,000.00 for the Events; and

WHEREAS, Clayton County youth teams will receive \$50.00 off the tournament entry fee; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by entering into two License Agreements with the Promoter for the Events as previously described.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to enter into two License Agreements with Challenger Sports Corporation (the “Promoter”) to utilize the volleyball area at Clayton County International for a TetraBrazil Beach Soccer Camp and a Beach Soccer Tournament (the “Events”) from June 2 through June 6, 2014 from 9:00 a.m. to 4:00 p.m., and from June 6 through June 8, 2014 from 7:00 a.m. to 7:00 p.m., respectively. The Board of Commissioners authorizes the Chairman to execute the License Agreements attached hereto as Attachments “A” and “B,” and otherwise perform all other acts necessary to accomplish the intent of this Resolution.

Section 2. The Board of Commissioners approves the Department’s recommended event rental fee of a total of \$3,000.00 for the Events.


Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements prior to the initial Event date as provided by the Clayton County Risk Management Department.

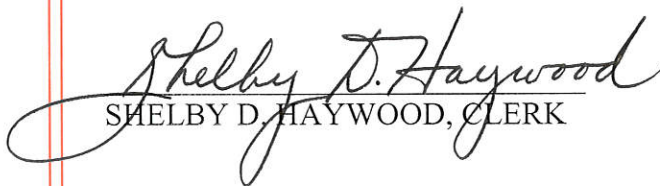
