RESOLUTION NO. 2014 - 186

A RESOLUTION AUTHORIZING CLAYTON COUNTY, ON BEHALF OF THE CLAYTON COUNTY PARKS AND RECREATION DEPARTMENT, TO GRANT A SPECIAL FACILITY USE REQUEST FOR THE ROTARY CLUB OF CLAYTON COUNTY, INC. TO HOST A SERIES OF EVENTS FOR INTERNATIONAL COLLEGE STUDENTS AT THE CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Parks and Recreation Department received a Special Facility Use Request from the Rotary Club of Clayton County, Inc. (the "Request") for use of the VIP Building (Level 1), St. Martin Pavilion and Nassau Building at the Clayton County International Park (the "Park") for the purpose of hosting a meet and greet, group activities, dinner and a farewell departure for 40 to 50 international college students, for team building activities; and

WHEREAS, the Park space will be utilized between the hours of 3:00 p.m. on September 5, 2014 and culminating at 11:30 a.m. on September 7, 2014; and

WHEREAS, the Board of Commissioners desires to waive the Special Event Fee (\$350.00), and Rotary Club of Clayton County, Inc. will pay for the services of one Event Maintenance Staff person (\$10 per hour for four hours—\$40.00), two Lifeguards (\$10.00 per hour for three hours each—\$60.00) and one Event Coordinator for safety and security purposes (\$10 per hour for nine hours—\$90.00) during the event; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by granting the Request of the Park space for the stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, on behalf of the Clayton County Parks and Recreation Department, to grant the Rotary Club of Clayton County, Inc. a Special Facility Use Request to host a meet and greet, group activities, dinner and a farewell departure for 40 to 50 international college students at the VIP Building (Level 1), St. Martin Pavilion and Nassau Building at Clayton County International Park between the hours of 3:00 p.m. on September 5, 2014 and culminating at 11:30 a.m. on September 7, 2014, and also authorizes the Chairman to execute any documents and perform any other acts necessary to accomplish the intent of this Resolution.


Section 2. Rotary Club of Clayton County, Inc. will pay for the services of one Event Maintenance Staff person (\$10 per hour for four hours—\$40.00), two Lifeguards (\$10.00 per hour for three hours each—\$60.00) and one Event Coordinator for safety and security purposes (\$10 per hour for nine hours—\$90.00) during the event.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements prior to the initial event date as provided by the Clayton County Risk Management Department.




