A RESOLUTION TO CREATE THE 911 COMMUNICATIONS CENTER DEPARTMENT; TO CREATE THE POSITION OF DIRECTOR OF THE 911 COMMUNICATIONS CENTER DEPARTMENT; TO ADOPT A JOB DESCRIPTION FOR THE POSITION; TO APPOINT A DIRECTOR OF THE 911 COMMUNICATIONS CENTER DEPARTMENT; TO AUTHORIZE THE CHAIRMAN TO PERFORM ANY ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET AS NEEDED TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO AUTHORIZE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Board of Commissioners deems it in the best interest of the County and that the County will best be served by the creation of a department devoted exclusively to the management of 911 operations for the County; and

WHEREAS, said department will need a Director to perform the duties and responsibilities as described in the Job Description attached hereto and identified as Attachment "A".

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby creates the 911 Communications Center Department.

Section 2. The Board of Commissioners hereby creates the position of Director of the 911 Communications Center Department.

Section 3. The Board of Commissioners hereby adopts the Job Description for the position of Director of the 911 Communications Center Department, which is attached hereto as Attachment "A".

Section 4. The Board of Commissioners will appoint a Director of the 911 Communications Center Department with the appropriate skills, knowledge and experience to perform the duties and responsibilities as described in the Job Description.

Section 5. The Board authorizes the Chairman to perform any acts necessary to accomplish the intent of this Resolution. Additionally, the Board authorizes the Chief Financial Officer to amend the Budget as needed to reflect an appropriate revenue source and expense.

Section 6. This Resolution shall be effective on the date of its approval.


