RESOLUTION NO. 2015-150

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO PARTICIPATE IN THE "WORLD'S LARGEST SWIMMING LESSON" EVENT TO BE CONDUCTED AT THE CARL RHODENIZER RECREATION CENTER, STEVE LUNDQUIST AQUATIC CENTER, VIRGINIA GRAY RECREATION CENTER AND SOUTH CLAYTON RECREATION CENTER; TO AUTHORIZE THE CHAIRMAN TO EXECUTE A SCHOLARSHIP APPLICATION TO RECEIVE A WAIVER OF THE HOST FACILITY COSTS, AS WELL AS FOUR HOST FACILITY LIABILITY AND PUBLICITY RELEASE FORMS, AND OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Association of Pool & Spa Professionals, International Swimming Hall of Fame, International Swim Instructors Association, Independent Pool & Spa Service Association, Jeff Ellis & Associates, National Aquatic Safety Company, National Recreation & Park Association, Starfish Aquatics Institute, Swim For Life Foundation, United States Swim School Association, World Waterpark Association, and others have collaborated to act as "Presenting Organizations" for the World's Largest Swimming Lesson (the "Event"), which will occur simultaneously at numerous facilities on June 18, 2015; and

WHEREAS, in an effort to help promote May as nationally recognized Water Safety Month, Clayton County, through its Parks and Recreation Department, desires to participate in the Event by providing the Carl Rhodenizer Center, Steven Lundquist Aquatic Center, Virginia Gray Recreation Center and South Clayton Recreation Center as host facilities; and

WHEREAS, the County is solely responsible for providing personnel for facility maintenance, safety, and security at the Event; and

WHERAS, the cost to host the Event is \$20.00 per facility, however the Event organizers have permitted the County to submit a scholarship application whereby, if granted, the cost for the County to host the Event will be waived; and

WHEREAS, the County is required to sign Host Facility Liability and Publicity Releases to give the Guinness World Records and the Presenting Organizations and their affiliates permission to legally use, publish and display County facilities, among other purposes; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by executing the necessary documentation to participate in the Event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County, through its Parks and Recreation Department, to participate in the "World's Largest Swimming Lesson" event (the "Event") on June 18, 2015 at the Carl Rhodenizer Center, Steven Lundquist Aquatic Center, Virginia Gray Recreation Center and South Clayton Recreation Center. The Board of Commissioners authorizes the Chairman to execute for each facility Host Facility Liability and Publicity Releases which are attached hereto as Attachments "A," "B," "C," and "D", and the scholarship application attached hereto as Attachment "E" to allow the County to host the Event at no cost, and otherwise perform all acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be immediately effective upon approval by the Board of Commissioners.
