RESOLUTION NO. 2015-33

A RESOLUTION AUTHORIZING THE CLAYTON COUNTY DEPARTMENT OF SENIOR SERVICES, ON BEHALF OF CLAYTON COUNTY, TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH THE ATLANTA REGIONAL COMMISSION PROVIDING FOR TERMS AND CONDITIONS PERTAINING TO THE RETIRED AND SENIOR VOLUNTEER PROGRAM; TO AUTHORIZE THE CHAIRMAN OR THE DIRECTOR OF SENIOR SERVICES AS HIS DESIGNEE TO EXECUTE THE MOU; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Department of Senior Services has historically collaborated with the Atlanta Regional Commission (“ARC”) for the planning and delivery of the Retired and Senior Volunteer Program (“RSVP”) in Clayton County; and

WHEREAS, RSPV provides civic engagement opportunities for adults aged 55 years and above to help maintain independent, healthy lifestyles and the creation of sustainable lifelong communities; and

WHEREAS, Senior Services will assist RSVP in various ways including the provision of staff support for program management and implementation, by providing ongoing volunteer recruitment and site placement, and by providing space, resources and supervision needed for RSVP volunteers to perform daily tasks; and

WHEREAS, there is no budgetary impact on the County in connection with RSVP; and

WHEREAS, Senior Services, on behalf of Clayton County, and the ARC wish to enter into a Memorandum of Understanding to memorialize the working relationship between both parties; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County and the County will best be served by entering into a Memorandum of Understanding with the Atlanta Regional Commission for the reasons contemplated herein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the Senior Services Department, on behalf of Clayton County, to enter into a Memorandum of Understanding with the Atlanta Regional Commission providing for terms and conditions pertaining to the Retired and Senior Volunteer Program. The MOU is attached hereto. The Board authorizes the Chairman or the Director of Senior Services as his designee to execute the MOU.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
