RESOLUTION NO. 2015 - 224

A RESOLUTION AUTHORIZING THE ACCEPTANCE OF A CONDEMNED VEHICLE TO BE ASSIGNED TO THE CLAYTON COUNTY POLICE DEPARTMENT FLEET IN A MANNER AS WILL BE IN THE BEST INTEREST OF THE COUNTY; TO AUTHORIZE THE DIRECTORS OF CENTRAL SERVICES, AND FLEET MAINTENANCE TO PERFORM ALL ACTS REQUIRED BY THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Police Drug Task Force seized a 2002 Chevrolet Tahoe C1500, VIN 1GNEC13Z72J237747 during a drug investigation; and

WHEREAS, the Clayton County Police Drug Task Force did petition the District Attorney for forfeiture of said vehicle to the County; and

WHEREAS, the Superior Court of Clayton County has forfeited ownership and title of said vehicle to the County under court order in case number 2014-CV-03870-5; and

WHEREAS, the Director of Fleet Maintenance has determined that the vehicle sought to be condemned can be effectively used for the benefit of the County; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by accepting said vehicle and assigning it to the Clayton County Police Drug Task Force to enhance law enforcement in accordance with applicable State Statutes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to accept title to a 2002 Chevrolet Tahoe C1500, VIN 1GNEC13Z72J237747 seized during a

drug investigation; to assign said vehicle to the Clayton County Police Drug Task Force vehicle fleet for the purpose of enhancing law enforcement in accordance with Clayton County Superior Court order in case number 2014-CV-03870-5. The Board of Commissioners authorizes the Directors of Central Services, and Fleet Maintenance to perform all acts necessary to effect this Resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


