RESOLUTION NO. 2016 -11

A RESOLUTION AUTHORIZING THE ACCEPTANCE OF ONE CONDEMNED VEHICLE TO BE ASSIGNED TO THE POLICE DEPARTMENT FLEET IN A MANNER AS WILL BE IN THE BEST INTEREST OF THE COUNTY; TO AUTHORIZE THE DIRECTORS OF CENTRAL SERVICES AND FLEET MAINTENANCE TO PERFORM ALL ACTS REQUIRED BY THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Police Drug Task Force seized a 2001 Dodge Caravan Van, VIN 2B8GP54L31R322727, during a drug investigation; and

WHEREAS, the Clayton County Police Drug Task Force did petition the District Attorney for forfeiture of said vehicle to the County; and

WHEREAS, the Superior Court of Clayton has forfeited ownership and title of said vehicle to the County under court order in case number 2015-CV-01788-6; and

WHEREAS, the Director of Fleet Maintenance has determined said vehicle is suitable for service as a county vehicle; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County and the County will best be served by accepting said vehicle and assigning it to the Clayton County Police Drug Task Force to enhance law enforcement in accordance with applicable State Statutes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED




Directors of Central Services and Fleet Maintenance are authorized to perform all acts necessary to effect this resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.


