RESOLUTION NO. 2016-51

A RESOLUTION TO ENTER INTO A LICENSE AGREEMENT WITH LAKE SPIVEY COMMUNITY, INC. TO HOST THE "LAKE SPIVEY COMMUNITY FESTIVAL" AT THE UPPER FIELD AREA AT CLAYTON COUNTY INTERNATIONAL PARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Lake Spivey Community, Inc. (the "Promoter") wishes to utilize the Upper Field area at the Clayton County International Park (the "Location") to host a community event entitled, the "Lake Spivey Community Festival," which will include a DJ and food and alcohol to be sold in designated areas; and

WHEREAS, the Promoter wishes to utilize the Location in Jonesboro, Georgia on May 14, 2016 from approximately 8:00 A.M. until 11:00 P.M., with the purpose of providing citizens a place to be entertained in a family-friendly atmosphere; and

WHEREAS, the Director of the Parks and Recreation Department (the "Department") recommends the Department's half price rates (for registered, nonprofit home owners associations) for a Special Event Fee of \$350.00, an Event Coordinator Fee of \$260.00 for organization and safety purposes (\$20.00 per hour for 13 hours), an Event Maintenance Staff Fee of \$110.00 (one employee at \$10.00 per hour for 11 hours), and one County Police Officer for \$450.00 (\$45.00 per hour for 10 hours), for a total of \$1,170.00; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by allowing the Promoter to host this event for the total fee recommended above by the Department.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners authorizes Clayton County to enter into a License Agreement with Lake Spivey Community, Inc. (the "Promoter") providing for the terms and conditions under which the Upper Field area at the Clayton County International Park will be utilized to host the "Lake Spivey Community Festival," which will include a DJ, as well as food and alcohol to be sold in designated areas. The Board of Commissioners authorizes the Chairman to execute the License Agreement attached hereto as Attachment "A" and otherwise perform all acts necessary to accomplish the intent of this Resolution.

Section 2. The Board of Commissioners approves the Parks and Recreation Department's recommendation for a half priced Special Event Fee of \$350.00, an Event Coordinator Fee of \$260.00 for organization and safety purposes (\$20.00 per hour for 13 hours), an Event Maintenance Staff Fee of \$110.00 (one employee at \$10.00 per hour for 11 hours), and one County Police Officer for \$450.00 (\$45.00 per hour for 10 hours), for a total of \$1,170.00 to be charged to the Promoter to host the event.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon complete satisfaction of all insurance requirements prior to the initial event date as provided by the Clayton County Risk Management Department.
