RESOLUTION NO. 2016-64

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT BETWEEN THE COUNTY AND THE CITY OF COLLEGE PARK, GEORGIA CONCERNING THE USE OF THE COUNTYWIDE 700 MHZ COMMUNICATIONS SYSTEM.; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT ON BEHALF OF THE COUNTY AND OTHERWISE TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THE RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County, Georgia and the City of College Park, Georgia desire to utilize the Countywide 700 MHz Communications System; and

WHEREAS, pursuant to O.C.G.A. §§ 36-70-20 et seq. the Parties entered into a Clayton County Service Delivery Strategy in order to improve the efficiency of local government services, to eliminate the duplication of service delivery and double taxation, and to adapt to changing service demands in Clayton County; and

WHEREAS, the County has provisioned and maintains a Countywide 700 MHz Communications System for the purpose of public safety communications for all agencies within Clayton County; and

WHEREAS, the County desires to adhere to and comply with the minimum 75% channel loading, Design and Efficiency requirements of the Region 10 – State of Georgia 700 MHz Regional Plan; and

WHEREAS, the Region 10 – State of Georgia 700 MHz Regional Plan encourages smaller agencies to partner with larger entities to promote spectrum efficiency; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County and the County will best be served by entering into an Intergovernmental Agreement for the above stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the County to enter into an Intergovernmental Agreement on behalf of the Clayton County Department of Information Technology, with the City of College Park, Georgia to allow College Park to utilize the Countywide 700 MHz Communications System. The Agreement is attached hereto.

Section 2. The Board of Commissioners hereby authorizes the Chairman to execute the Agreement on behalf of the County and to perform all other acts necessary to accomplish the intent of this Resolution.

Section 3. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
