A RESOLUTION TO AUTHORIZE CLAYTON COUNTY TO ACCEPT A VEHICLE SEIZED FOR FORFEITURE BY THE CLAYTON COUNTY POLICE DEPARTMENT DRUG TASK FORCE; TO AUTHORIZE THE VEHICLE FOR COUNTY USAGE AND ASSIGN THE VEHICLE TO THE CLAYTON COUNTY POLICE DRUG TASK FORCE; TO AUTHORIZE CENTRAL SERVICES, FLEET MAINTENANCE AND THE CHIEF FINANCIAL OFFICER TO TAKE ALL ACTIONS NECESSARY TO ACHIEVE THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Police Drug Task Force seized a 2006 Lincoln Mark LT, VIN 5LTPW16546FJ05911, during a drug investigation; and

WHEREAS, the Clayton County Police Drug Task Force petitioned the District Attorney for forfeiture of said vehicle to the County and the Superior Court of Clayton County has forfeited ownership and title of said vehicle to the County under a court order in case number 2015-CV-04608-6; and

WHEREAS, Fleet Maintenance has determined said vehicle is excellent condition and has recommended the unit for service as a County vehicle; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by placing said vehicle in the Clayton County Police Department's Fleet for use by the Police Drug Task Force in accordance with applicable State Statutes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

Section 1. The Board of Commissioners hereby authorizes Clayton County to accept title to a 2006 Lincoln Mark LT, VIN 5LTPW16546FJ05911 seized during a drug investigation and to assign said vehicle to the Clayton County Police Department for the purpose of enhancing law enforcement.

Section 2. The Board of Commissioners authorizes Central Services, Fleet Maintenance, and Chief Financial Officer to perform all acts necessary to effect this resolution.
