RESOLUTION NO. 2018 – 31

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE CITY OF JONESBORO FOR THE 2018 SUMMER CONCERT SERIES; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE RELATING THERETO; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the City of Jonesboro (“the City”) desires to hold several concerts within the City during the summer of 2018; and

WHEREAS, Clayton County (“the County”) also desires to hold several concerts during the summer of 2018; and

WHEREAS, the City and the County believe that it is in the best interests of the City and County to collaborate together to establish the 2018 Summer Concert Series (“Concert Series”); and

WHEREAS, the City and the County desire to enter into an intergovernmental agreement to establish the parameters of this collaboration for the Concert Series; and,

WHEREAS, the County has the power and authority to enter into an intergovernmental agreement with the City, and that the execution, delivery, and performance of certain duties relating to the 2018 Summer Concert series such as providing security personnel along with certain marketing and promotional efforts are within the County’s authority to perform.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED


Section 1. The Board of Commissioners hereby authorizes Clayton County to enter into an Intergovernmental Agreement with the City of Jonesboro to assist the City with venue setup, provide security personnel, provide an investment of up to \$20,000 for use towards the expenses of the Concert Series, provide fireworks for the July 7, 2018 City Concert and assist with the marketing and promotion of the Concert Series (collectively referred to as "Concert Services.") The Board authorizes the Chairman to execute the Agreement and to otherwise perform all acts necessary to accomplish the intent of this Resolution. The Board also authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense relating thereto. The Agreement shall be in substantially the form attached hereto.


Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
