RESOLUTION NO. 2018 - 53

A RESOLUTION AUTHORIZING THE CHIEF OF POLICE, AS THE CHAIRMAN'S DESIGNEE, TO EXECUTE A MEMORANDUM OF UNDERSTANDING WITH THE GEORGIA BUREAU OF INVESTIGATION TO PARTICIPATE IN THE GEORGIA INTERNET CRIMES AGAINST CHILDREN TASK FORCE; TO AUTHORIZE THE DIRECTOR OF INFORMATION TECHNOLOGY TO ASSIST AS NECESSARY WITH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Georgia Bureau of Investigation (GBI) oversees the Georgia Internet Crimes Against Children Task Force, which is a multi-agency effort to detect, investigate, apprehend and prosecute individuals who exploit children over the internet through the use of computers or other digital media; and

WHEREAS, the Clayton County Police Department wishes to participate in this effort to protect our children; and

WHEREAS, the GBI has limited grant funds available to provide equipment and training for the Task Force; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will be best served by participating in the Georgia Internet Crimes Against Children Task Force.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes the Chief of Police, as the Chairman's designee, to execute a Memorandum of Understanding with the Georgia Bureau of Investigation (GBI) to participate in the Georgia Internet Crimes Against Children Task Force. The Police Department is authorized to accept a loan of computer equipment to be used in this effort and to allow this equipment to be used as necessary on the County's computer network. The County is authorized to accept grant money to be used to train our officers who are participating in the Task Force with no matching county funds. The Director of Information Technology is authorized to assist the Police Department as necessary to carry out the intent of this resolution which will include allowing the computer equipment loaned by the GBI to be connected to the County's network. The Chief Financial Officer is authorized to amend the budget where necessary to reflect an appropriate revenue source and expense.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
