RESOLUTION NO. 2018-118

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY, GEORGIA AUTHORIZING THE CERTIFICATION AND SUBMITTAL OF THE COUNTY'S PHASE ONE LARGE MUNICIPAL SEPARATE STORM SEWER SYSTEM (MS4) NATIONAL POLLUTANTS DISCHARGE ELIMINATION SYSTEM PERMIT REAPPLICATION FORM TO THE STATE OF GEORGIA'S ENVIRONMENTAL PROTECTION DIVISION; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Board of Commissioners ("the County") currently holds a National Pollutants Discharge Elimination System permit ("NPDES Permit) from the Georgia Environmental Protection Division ("EPD") for its Phase 1 Large Municipal Separate Storm Sewer System ("Storm Sewer System") and said NPDES Permit expires on June 10, 2019; and

WHEREAS, the NPDES Permit authorizes the County to discharge stormwater from the County's Storm Sewer System to the waters of the State of Georgia; and

WHEREAS, the County has contracted storm sewer related activities in the unincorporated area of the County to the Clayton County Water Authority ("CCWA") pursuant to Resolution 2004-209 and the CCWA has prepared all necessary documentation to keep the County compliant with the requirements of the NPDES Permit; and

WHEREAS, pursuant to the requirements of the Federal Clean Water Act and the Georgia Water Quality Control Act, the County is required to apply to renew its permit no later than December 12, 2018; and

WHEREAS, the County deems it in the best interest of the County and the County will best be served by submitting the reapplication form to the EPD for the NPDES Permit.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to submit all necessary documentation to the Georgia Environmental Protection Division and any other required entity to keep the County's Phase 1 Large Municipal Separate Storm Sewer System complaint with the requirements of the National Pollutants Discharge Elimination System Permit which is currently scheduled to expire on June 10, 2019. The Board authorizes the Chairman to execute the Agreement and to otherwise perform all acts necessary to accomplish the intent of this Resolution.

<u>Section 2.</u> The effective date of this Resolution shall be when approved by the Board of Commissioners of Clayton County.
