RESOLUTION NO. 2019 – 59

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO APPLY FOR AND ACCEPT THE YSA LEAD AGENCY GRANT FROM CHARLES STEWART MOTT FOUNDATION AND CORPORATION FOR NATIONAL AND COMMUNITY SERVICE; TO AUTHORIZE THE CHAIRMAN TO EXECUTE THE AGREEMENT AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE RELATING THERETO; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, research shows volunteering is a gateway to civic participation and volunteers are more likely to help their neighbors, join civic organizations, vote, and donate to charity; and

WHEREAS, Youth Service America (“YSA”) collaborates with Lead Agencies to ask young people to get involved with volunteering efforts; and

WHEREAS, YSA offers a grant funded by the Charles Stewart Mott Foundation and Corporation for National and Community Service to engage youth volunteers, especially middle and high-school aged students from underserved communities, on 9/11 Day of Service & Remembrance, MLK Day of Service, and Global Youth Service Day through YSA’s 2019-2020 Lead Agency program; and

WHEREAS Clayton County (“the County”) finds that it is in the best interest of the County and the County will best be served by creating a culture in which the youth of the

County will have the opportunity and support to find their voice, take action, and make an impact in their community;

WHEREAS, the County desires to apply for grant funding up to \$9,000 from YSA to activate youth volunteers to promote volunteerism, community support and improvement of the health and welfare of its citizens.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF  
CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to apply for and accept the YSA's 2019-2020 Lead Agency Grant funded by the Charles Stewart Mott Foundation and Corporation for National and Community Service in an amount up to \$9,000. The Board authorizes the Chairman to execute the Agreement and to otherwise perform all acts necessary to accomplish the intent of this Resolution. The Board also authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense relating thereto.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.






