## **RESOLUTION NO. 2019 – 127**

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO APPLY FOR AND ACCEPT GRANT FUNDS FROM UNITED STATES DEPARTMENT OF JUSTICE FOR ADULT DRUG COURT FUNDING; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY AGREEMENT AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE RELATING THERETO; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS the United States Department of Justice has provided funds to enhance Adult Drug Courts to operate courts in FY19-22 and expand access to evidence-based treatment services for drug abusing offenders of the Clayton County Adult Felony Drug Court Program, including treatment, mental health services, and training; and

WHEREAS the Clayton County Adult Felony Drug Court is a four-phase intervention program that involves intensive group and individual counseling, frequent court appearances, probation supervision, random drug testing, and home surveillance visits over a minimum of 18 months and has graduated 72 individuals since its implementation in 2009; and

WHEREAS, the County desires to apply and accept grant funding in the amount of \$479,520.00 from the United States Department of Justice to fund the Adult Felony Drug Court and finds that it is in the best interests and welfare of the County's citizens to do so.

## NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to apply for and accept a grant in the amount of \$479,520.00 from the United States Department of Justice for funding of the Clayton County Adult Drug Court. The Board authorizes the Chairman to execute any Agreement and to otherwise perform all acts necessary to accomplish the intent of this Resolution. The Board also authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense relating thereto.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
