RESOLUTION NO. 2020 - 212

A RESOLUTION TO RESCIND THE OCTOBER 20<sup>TH</sup>, 2020 UNANIMOUS MOTION TO APPROVE THE REQUEST FOR AN INCREASE IN SUPPLEMENTAL SALARY FOR THE SOLICITOR GENERAL; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Solicitor General requested a compensation review and consideration of an increase in supplemental salary compensation from the Board; and

WHEREAS, Resolution 2014-202 adopted on August 19, 2014, provides a \$13,333 salary supplement for the Solicitor General; and

WHEREAS, Resolution 2014-202 also provides for salary supplements for other elected and appointed persons; and

WHEREAS, on October 20, 2020, the Board of Commissioners voted to approve an increase in supplemental pay to the Solicitor General and considered, in part, the existence of the supplemental pay pursuant to Resolution 2014-202; and

WHEREAS, subsequent to the October 20, 2020 vote to approve the recommendation to provide additional supplemental pay to the Solicitor General, the Board has become aware of additional requests for compensation by other officials; and

WHEREAS, the County now desires to rescind the October 20<sup>th</sup>, 2020 motion to approve the recommendation to provide additional supplemental pay to the Solicitor General until such time that the Board can study the fiscal impact of supplemental pay increases that impact Resolution 2014-202 and the funding source for same.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby rescinds its October 20th, 2020 motion to approve the recommendation to provide additional supplemental pay to the Solicitor General until such time that the Board can study the fiscal impact of supplemental pay increases that impact Resolution 2014-202 and the funding source for same.


Section 2. This Resolution shall be effective immediately upon approval by the Board of Commissioners.


