A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ALLOW CLAYTON COUNTY LIBRARY SERVICES DEPARTMENT TO UTILIZE CLAYTON COUNTY INTERNATIONAL PARK AS A PLACE TO INSTALL A FREE LITTLE LIBRARY; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS RELATING THERETO AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County Parks and Recreation Department is requesting Board of Commissioners consider a request submitted by Isabel Donaldson, to utilize Clayton County International Park as a place to install a Free Little Library (the "Little Library") for her Middle School Beta Club project; and

WHEREAS, the Little Library will be placed near the playground for members of the community to share books; and

WHEREAS, the Little Library will be officially registered at https://littlefreelibrary.org/, allowing people to enter their Jonesboro zip code on the website and find the Little Library.

WHEREAS, Isabel Donaldson and her mother will keep the library stocked and will check weekly to make sure books are still available; and

WHEREAS, Isabel Donaldson has raised over \$400 to purchase the Little Library; and WHEREAS, there is no financial impact to the County; and

WHEREAS, the Board deems it in the best interest of the County and the County will best be served by utilizing Clayton County International Park as a place to install a Free Little Library for that stated purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, on behalf of Clayton County Parks and Recreation Department, to utilize Clayton County International Park as a place to install a Free Little Library for a school Beta Club project. The Board also authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
