RESOLUTION NO. 2020-226

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ALLOW VENUS PURPOSE INC. TO USE THE HEADQUARTERS' LIBRARY FRONT PARKING LOT FOR A THANKSGIVING BOX FOOD DISTRIBUTION SITE ON NOVEMBER 21, 2020; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS RELATING THERETO AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Venus Purpose Inc. provides housing and supportive services to pregnant parenting teens and young adult mothers located in Clayton County; and

WHEREAS, the Venus Purpose Inc. group is seeking a safe location for the distribution of Thanksgiving meals on November 21,2020 from 12:00pm – 2:00pm; and

WHEREAS, the library parking lot is a location that can easily be converted to a stage drive by services and keep traffic flowing; and

WHEREAS, everyone will remain in their vehicles while the boxes are delivered to their cars; and

WHEREAS, this event will be a significant help to Clayton County citizens who are affected by COVID-19 and are in need of food as well as those who need food specifically during this holiday period; and

WHEREAS, the Board deems it in the best interest of the County and the County will best be served by accepting the grant funds for the stated purposes.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS

OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County, on behalf of Clayton County Library Services Department, to allow Venus Purpose Inc to use the Headquarters' Library Front Parking Lot for a Thanksgiving Box food distribution site on November 21, 2020. The


Board also authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution.




