RESOLUTION NO. 2020 - 76

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO DESIGNATE ITS CLAYTON COUNTY FIRE AND EMERGENCY SERVICES DEPARTMENT AS A DEPARTMENT OF PUBLIC HEALTH MODERATE TESTING SITE; TO AUTHORIZE THE CHAIRMAN OR HIS DESIGNEE TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, on March 13, 2020, the President of the United States declared the COVID-19 pandemic a national emergency; and

WHEREAS, the Georgia Department of Public Health is charged with providing the appropriate health response for the State of Georgia with regard to the COVID-19 pandemic; and

WHEREAS, pursuant to its authority under appropriate federal law, the Department of Public Health desires to assign temporary site status to the Clayton County Fire and EMS department to designate it as a moderate testing site; and

WHEREAS, this designation will allow the County to have access to emergency testing capacity pursuant to the State of Emergency declared by the State of Georgia (Executive Order 3.14.20.01) for First Responders and other Clayton County Government personnel during the duration of the State of Emergency; and

WHEREAS, given the uncertain time for resolution of the current State of Emergency, the temporary site status will be from April 16, 2020 through April 16, 2021; and

WHEREAS, the Board of Commissioners finds that it is in the best interests and welfare of the County's citizens to accept this temporary moderate testing site status for the Fire and Emergency Services department.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF
CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby accepts the Georgia Department of Health's directive to assign temporary site status to the Clayton County Fire and Emergency Services department as a moderate testing site along with the requirement to adhere to the practices and procedures applicable thereto. The Board authorizes the Chairman or his designee to perform all acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
