RESOLUTION NO. 2021-181

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ACCEPT FORFEITED PROPERTY PURSUANT TO THIRTY-ONE COURT ORDERS FOR OFFICIAL USE BY THE CLAYTON COUNTY POLICE DEPARTMENT; TO AUTHORIZE THE CHAIRMAN, OR THE CHIEF OF POLICE AS HIS DESIGNEE, TO ACCEPT THE PROPERTY ON BEHALF OF CLAYTON COUNTY, AND TO EXECUTE ANY DOCUMENTS NECESSARY, AND OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Police Department did petition the Superior Courts of Clayton County and Henry County to allow the Department to retain eighty-five (85) items of forfeited property; and

WHEREAS, the Superior Courts of Clayton County and Henry County did grant the petitions and issued court orders to retain said property for official use, pursuant to thirty-one (31) court orders, to include: 2013CV02700-8; 2013CV03459-6; 2013CV03770-6; 2013CV04656-5; 2013CV04617-6; 2014CV04616-8; 2014CV00749-9; 2014CV01231-5; 2014CV06718; 2014CV02373-5; 2014CV02440-8; 2014CV02507-9; 2014CV03463-9; 2014CV03791-9; 2014CV03899-5; 2014CV03748-5; 2014CV04759-9; 2014CV05034-9; 2014CV04127-9; 2014CV04758-8; 2014CV05042-8; 2014CV05444-6; 2015CV00955-6; 2015CV01191-5; 2015CV01803-5; 2015CV1261-WC (Henry County Superior Court Order); 2015CV01976-9; 2015CV0212-8; 2015CV02478-5; 2015CV02479-5; 2015CV02874-6; and

WHEREAS, the eighty-five (85) items are more fully described in the attached exhibit, and the exhibit and indicated court orders are adopted by reference and incorporated into this Resolution; and

WHEREAS, the eighty-five (85) items were forfeited to Clayton County, upon the disposition of the related criminal cases, pursuant to the aforementioned court orders and five (5) of the items will be destroyed due to being illegal or in poor condition; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County and the County will best be served by accepting the property for the above stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to accept certain property which is more fully described in the attached exhibit and court orders, to include: 2013CV02700-8; 2013CV03459-6; 2013CV03770-6; 2013CV04656-5; 2013CV04617-6; 2014CV04616-8; 2014CV00749-9; 2014CV01231-5; 2014CV06718; 2014CV02373-5; 2014CV02440-8; 2014CV02507-9; 2014CV03463-9; 2014CV03791-9; 2014CV03899-5; 2014CV03748-5; 2014CV04759-9; 2014CV05034-9; 2014CV04127-9; 2014CV04758-8; 2014CV05042-8; 2014CV05444-6; 2015CV00955-6; 2015CV01191-5; 2015CV01803-5; 2015CV1261-WC (Henry County Superior Court Order); 2015CV01976-9; 2015CV0212-8; 2015CV02478-5; 2015CV02479-5; 2015CV02874-6. The court orders and the Exhibit are hereby adopted by reference and incorporated into this Resolution. Said property, which is forfeited to the Clayton County Board of Commissioners, has been granted to the Clayton County Police Department for official use. Five (5) of the items will be destroyed, due to being illegal or in poor condition.

Section 2. The Board of Commissioners hereby authorizes the Chairman, or the Chief of Police as his designee, to execute any documents necessary, and otherwise perform all acts

necessary to accomplish the intent of this Resolution. Further, the Board of Commissioners hereby authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense, all as may be required.

Section 3. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
