A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH GOODWILL OF NORTH GEORGIA TO PROVIDE WORKSHOPS, TRAINING CLASSES, AND TECHNOLOGY WITH SUPPORT SERVICES TO THE COMMUNITY; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Library System (the "Library") wishes to enter into an agreement with Goodwill of North Georgia ("Goodwill") to provide resources such as workshops, training classes, and technology along with support services to the Clayton County community; and

WHEREAS, the Library wishes to promote ongoing professional growth, provide opportunities for individuals with abilities and barriers to employment, and advocate for the opportunities for these individuals with local employers; and

WHEREAS, the Library and Goodwill will work together to host a job fair and workshops with informational sessions; and

WHEREAS, entering into this Memorandum of Understanding will equip individuals with employable skills through job training programs and employment services; and

WHEREAS, there is no cost to the County; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by entering into the Memorandum of Understanding with Goodwill for the above stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

<u>Section 1</u>. The Board of Commissioners hereby authorizes Clayton County to enter into a Memorandum of Understanding with Goodwill of North Georgia to provide resources such as

workshops, training classes, and technology along with support services to the Clayton County community. The Memorandum of Understanding shall be in substantially the form attached, hereto as Exhibit "A", subject to such minor changes, insertions, or deletions as the County Attorney and or Chairman of the Board of Commissioners may approve. The Board of Commissioners hereby authorizes the Chairman, or his designee, to execute the Agreement, with such minor changes, insertions, or deletions, and otherwise to perform all other acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
