A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A SETTLEMENT AGREEMENT AND GENERAL RELEASE SETTLING ALL CLAIMS SET FORTH IN THE MATTERS INVOLVING JACQUELYN WILSON; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO AUTHORIZE THE CHIEF FINANCIAL OFFICER TO AMEND THE BUDGET WHERE NECESSARY TO REFLECT AN APPROPRIATE REVENUE SOURCE AND EXPENSE, ALL AS MAY BE REQUIRED UNDER THE TERMS OF THE SETTLEMENT AGREEMENT; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, Clayton County wishes to enter into an "Agreement and General Release" (hereinafter "Settlement Agreement") to settle all matters involving Jacquelyn Wilson in return for a full and final release of all claims, suits, causes of action, grievances, or other liability asserted against the County as outlined in the Settlement Agreement; and

WHEREAS, the Board of Commissioners deems it in the best interest of Clayton County, and the County will best be served by authorizing the Settlement Agreement as contemplated herein.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS
OF CLAYTON COUNTY, GEORGIA, AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to enter into a Settlement Agreement, settling any and all claims, suits, causes of action, grievances, or other liability asserted against the County as outlined in the Settlement Agreement attached hereto.

Section 2. Further, the Board of Commissioners hereby authorizes the Chairman to perform all acts necessary to accomplish the intent of this Resolution.

Section 3. The Board of Commissioners hereby authorizes the Chief Financial Officer to amend the Budget where necessary to reflect an appropriate revenue source and expense, all as may be required under the terms of the Settlement Agreement.

Section 4. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
