RESOLUTION NO. 2022-141

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO ENTER INTO A MEMORANDUM OF UNDERSTANDING WITH BLUE RECRUIT TO PROVIDE A FREE PATH TO EMPLOYMENT FOR CLAYTON COUNTY RESIDENTS THAT PARTICIPATE IN THE INTERPLAY SKILLED TRADES LEARNING PROGRAM; TO AUTHORIZE THE COUNTY TO HOST THE WORKSHOPS AT THE COUNTY'S LIBRARY LOCATIONS; TO AUTHORIZE THE CHAIRMAN TO EXECUTE ANY DOCUMENTS AND TO OTHERWISE PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the County, through the Clayton County Library System (the "Library"), wishes to enter into a Memorandum of Understanding ("MOU") with Blue Recruit, Inc. ("Blue Recruit") to provide a free path to employment for Clayton County residents that participate in the Interplay Skilled Trades learning program; and

WHEREAS, Blue Recruit alleviates the hassle of looking for a new job; and

WHEREAS, the Library will provide a landing page with Blue Recruit which will guide participants through the work experience profile creation process with the ability to add their Interplay course credits to their profile; and

WHEREAS, the participant's profile contains all the key information such as experiences, salary requirements, location, and certifications at no cost to the participant; and

WHEREAS, once the participant's profile is complete, companies can find them and will contact them directly to schedule an interview; and

WHEREAS, there is no cost to the County; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by entering into the Memorandum of Understanding with Blue Recruit for the above stated purpose.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS  
OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to enter into a Memorandum of Understanding with Blue Recruit, Inc. to provide a free path to employment for Clayton County residents that participate in the Interplay Skilled Trades learning program. The Memorandum of Understanding shall be in substantially the form attached hereto as Exhibit "A", subject to such minor changes, insertions, or deletions as the County Attorney and/or Chairman of the Board of Commissioners may approve. The Board of Commissioners hereby authorizes the Chairman, or his designee, to execute the Agreement, with such minor changes, insertions, or deletions, and otherwise to perform all other acts necessary to accomplish the intent of this Resolution.

Section 2. This Resolution shall be effective on the date of its approval by the Board of Commissioners.
