RESOLUTION NO. 2022-173

A RESOLUTION AUTHORIZING CLAYTON COUNTY TO GRANT A SPECIAL FACILITY USE REQUEST TO DIVINE FAITH MINISTRIES INTERNATIONAL TO HOST A FAMILY PICNIC AT SPIVEY SPLASH WATERPARK; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, a Special Facility Use Request (the "Request") was received from Divine Faith Ministries International ("DFMI") (the "Promoter"), to utilize Spivey Splash Waterpark (the "Facility") to host their DFMI's Family Picnic (the "Event") on September 17th, 2022; and

WHEREAS, the Promoter would like to use the Facility from 9:00 A.M. to 6:00 P.M.; and WHEREAS, the anticipated number of people attending the Event is between 1500-2000 people; and

WHEREAS, the Promoter would like to utilize the entire facility during the requested times; and

WHEREAS, Clayton County Parks and Recreation department is recommending the Promoter fee of \$9,800.00 be reduced to \$4,900.00 for this Event; and

WHEREAS, this Promoter fee includes the costs for a gate and game attendant, a coordinator fee, a lifeguard employee fee, and a maintenance employee fee; and

WHEREAS, the Board of Commissioners deems it in the best interest of the County, and the County will best be served by granting the Request to use the Facility and allowing the Promoter to facilitate this event.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED

Section 1. The Board of Commissioners hereby authorizes Clayton County to grant a Special Facility Use Request to Divine Faith Ministries International to utilize Spivey Splash

Waterpark to host a Family Picnic on September 17th, 2022. The Board of Commissioners further authorizes the Promoter to use the Facility from 9:00 A.M. to 6:00 P.M, which includes the setup and breakdown time.

Section 2. The Board of Commissioners authorizes the County to reduce the \$9,800.00 fee for the Event to \$4,900.00. The Board further authorizes the Chairman to execute any documents and perform any other acts necessary to accomplish the intent of this Resolution.

Section 3. This Resolution shall be immediately effective upon approval by the Board of Commissioners and is contingent upon the complete satisfaction of all insurance requirements, if any, prior to the initial event date as provided by Clayton County Risk Management.
