## RESOLUTION NO. 2022 - 239

A RESOLUTION OF THE CLAYTON COUNTY BOARD OF COMMISSIONERS AUTHORIZING THE USE OF THE SOUTH CLAYTON RECREATION CENTER FOR A RISK LIMITING AUDIT FOR THE 2022 NOVEMBER GENERAL ELECTION AS RECOMMENDED BY THE CLAYTON COUNTY BOARD OF ELECTIONS; TO AUTHORIZE THE CHAIRMAN TO PERFORM ALL OTHER ACTS NECESSARY TO ACCOMPLISH THE INTENT OF THIS RESOLUTION; TO PROVIDE AN EFFECTIVE DATE OF THIS RESOLUTION; AND FOR OTHER PURPOSES.

WHEREAS, the Clayton County Board of Elections and Registration ("Board of Elections") has recommended that it conduct its risk limiting audit associated with the 2022 November General Election from Thursday, November 17, 2022, through Tuesday, November 2022 to include the weekend; and

WHEREAS, the Board of Elections has requested use of the South Clayton Recreation Center's gymnasium as the facility to carry out the risk limiting audit as required by State law; and

WHEREAS, the Clayton County Board of Commissioners has determined that use of the South Clayton Recreation Center at the dates recommended by the Clayton County Board of Elections and Registration for the risk limiting audit is in the best interest of all parties to allow the Board of Elections to carry out its required statutory duties.

NOW THEREFORE, BE IT RESOLVED BY THE BOARD OF COMMISSIONERS OF CLAYTON COUNTY, GEORGIA AND IT IS HEREBY RESOLVED THAT

Section 1. The Board of Commissioners hereby authorizes the Clayton County

Board of Elections and Registration to use the South Clayton Recreation Center gymnasium

to carry out the risk limiting audit for the 2022 November General Election with said risk limiting audit to be conducted beginning on Thursday, November 17, 2022, through Tuesday, November 22, 2022, to include Saturday, November 19<sup>th</sup> and Sunday, November 20<sup>th</sup>.

Section 2. The Board authorizes the Chairman to perform all other acts necessary to accomplish the intent of this Resolution.

Section 3. This Resolution shall be effective upon the date of its approval by the Board of Commissioners.
