Business Taken Up By The Board:

1. Approval of previous meetings minutes

David Allen (then Secretary) indicates that there were no known issues Artie Jones moves that previous meeting minutes are adopted as presented Seconded by Mike Meade

2. Adoption of Conflict of Interest policy

Artie Jones moves to accept documents as presented Latrice Mitchell seconds motion 10 ayes; 0 nays

3. Election of officers

- Brief discussion on who will keep minutes, agreed by all that Jett Law Group keep minutes, James Shelby moves, Artie Jones seconds and all in favor
- Latrice Mitchell nominates herself as Chair, no other people put forward themselves
 - o Mike Meade moves to close nomination for chair Rebeka Wright seconds
 - o 10 ayes; 0 nays
 - o Latrice Mitchell is elected Chair

Marie Grigsby arrives

- Nomination for Vice Chair
 - o Rebeka Wright nominates James Shelby Marti Tracy seconds
 - Latrice Mitchell nominates Artie Jones, Artie Jones declines nomination and moves to close nomination for Vice Chair Mike Meade seconds
 - o 11 Ayes; 0 nays
 - o James Shelby is elected Vice Chair
- Nomination for Secretary
 - o James Shelby nominates David Allen, Rebeka Wright Seconds
 - o Mike Meade, moves to close nominations Artie Jones Seconds
 - o 11 ayes; 0 nays
 - o David Allen is elected Secretary
- Nomination for Treasurer- no nominations
 - o Seat remains unfilled until a later date
 - o Artie moves to close Marti Tracy seconds
 - o 11 ayes; 0 nays
 - o No Treasurer elected

4. Update from Legal Counsel – presented by Allie Jett

- Discussion of contents of information contained on the Land Bank's website
 - Artie Jones moves that Board member's emails be removed, that Jett Law Group act as Land Bank staff and be listed as the point of contact on the website
 - David Allen seconds motion
 - o 11 ayes; 0 nays
- Discussion of inventory of properties
 - o Inventory on website likely not accurate; efforts to obtain an accurate inventory are ongoing
 - Notation of naming discrepancy (CCLBA v. CCLB)
- Discussion of how properties in the Land Bank inventory are maintained
 - Legal obligation of maintenance and possible delegation of responsibilities to member governments
- Discussion of redemptions of properties, status of two or potentially three redemptions which had been tendered to Foster Foster & Smith, legal timeline for turning around redemption deeds, and how signatures on same are to be handled
 - Latrice Mitchell moves for Chair to be primary signatory, then Vice Chair if Chair is unavailable; if neither the Chair nor Vice Chair are available to sign and return within five days, then Counsel to have authority to sign as Authorized Representative for the Land Bank
 - o Artie Jones seconds
 - o 11 ayes; 0 nays
 - Rebeka Wright and James Shelby request that Counsel notify the Board when redemption funds are tendered

5. Discussion on By-laws and Administrative Policies and Procedures Update

- Board unanimously would like to update both documents
- Rebekah Wright requested that there be a google doc be created for input into potential revisions
- Counsel will collect all revisions and make recommendation for revisions at following meeting

James Shelby had to leave.

6. Discussion of Budget

- Counsel has been provided no previous accounting of properties transferred out of the Land Bank or funds received on behalf of Land Bank; counsel is working on obtaining that information.
- James Shelby asked about insurance of Board Members and participation of cities, Artie Jones requested that Counsel inquire as to the existence of any insurance covering the Land Bank through the County
- Discussion on how properties are maintained and requirements for funding for such maintenance
- Rebeka Wright would like to get every mayor of each city involved in understanding what the Land Bank does
- Artie Jones wants a meeting with Clayton County Board to take care of expenses in the mean time until the budget is resolved.
- At recommendation of Artie Jones, a sub committee was formed to discuss budget and funding matters
 - o Rebecka Wright will head this subcommittee. Other members include Artie Jones, Marie Grisby, Deborah Lovelace and Greg Washington

7. Disposition of Land Bank Properties

- Discussion of bids approved at previous meetings
 - Counsel to review materials to identify properties and reach out to those bidders to confirm their continued interest and understanding of the terms of their winning bid and confirm whether any funds have been tendered.
 - No previously serving Board Member is aware of Purchase and Sale Contracts having been entered into or resolution of any issues pertaining to the extinguishment of taxes owed to the School District.
- Artie request that this be noted on the website that buyers be aware of what their responsibility after the bid is accepted.

Question from the public: Counsel explains how the Land Bank Board is comprised and how the Board members are selected.
